President's message

2022 has been another busy year for the members of the EIAA. My sincere thanks to all members of the executive for their hard work and tireless hours to ensure that we get all pertinent information out to our members.

We struck a by-law review committee in March of 2022. Our existing by-laws mandate that we review our by-laws every four years and the last review was in 2018. Three members of the executive volunteered and were selected to review the by-laws. Clark Redden, Ed Wright and myself did a review on the by-laws. My thanks to Clark and Ed. Following the review recommendations were made to the executive and approved. We held a special resolution meeting as per our existing by-laws with sixty days notice given to our secretary and thirty days to the membership. Approval was given by unanimous consent of all members and the change has been submitted to Corporate Registries.

A Lightning Protection Seminar was held on Friday-September30 and Saturday-October 1. This seminar was held virtually and was very well attended. The seminar was without charge to EIAA members and minimal charge to non-members. The seminar was presented by Simon Larter of Dobbyn Lightning Protection in Calgary.

The 2023 EIAA Electrical Technical Conference is scheduled to be presented on Friday-February 10 and Saturday-February 11. As the Conference was a resounding success it will be held with the same format as the 2022 Technical Conference.

The 2023 Annual General Meeting is scheduled to be presented on Saturday March 18 will be held virtually. My hope is that at some point these Annual General meetings will be held with the same component as the Technical Conferences.
